- 2. When applying for a replacement decal, ensure that the "previous decal issued" is indicated on the reverse side of this form in Section 2. If the decal was stolen a copy of the police report must be submitted and the decal may be replaced at no charge.
- 3. Submit this completed form along with applicable service fees to any county tax collector's office or license plate agency in Florida.

INSTRUCTIONS TO APPLY FOR A VESSEL CHANGE OF CLASS

- 1. Complete Sections 1, 2, 3 and 4 (where applicable) on the reverse side of this form.
- 2. Attach the original copy of your current certificate of registration **OR** specify in Section 3 (A), on the reverse side of this form, why your current registration is not available.
- 3. If you are a non-resident/alien and are changing the classification of your vessel from a recreational craft to commercial craft, an additional \$50 commercial vessel fee is required. A Saltwater Products License is required of all individuals who sell saltwater products in Florida. Contact the Commercial Saltwater License Section (850-487-3122) of the Florida Fish and Wildlife Conservation Commission to obtain cost of any required licenses or permits.
- 4. Please note that a non-resident/alien is a person who has not maintained a continuous residence in Florida for a period of one year and has not actually resided in a given county for a period of six months immediately preceding the making of application for a license. An alien is a person who is not a citizen of the United States, although such a person may be a resident of Florida.
- 5. Submit this completed form along with applicable service fees to any county tax collector's office or license plate agency in Florida.
