TOP Issuance

Effective October 1, 2011, Temporary Operational Permits will no longer be available for issuance in Tax Collector offices. Transactions establishing new IRP accounts should be processed at the Commercial Vehicle Driver Services Walk-in office in the Neil Kirkman Building or via the mail through the Bureau. Applications that are accurately and completely filled out and contain all applicable supporting documents are usually processed within 3 to 5 business days. Please mail all IRP Applications to the Department of Highway Safety and Motor Vehicles, Bureau of Commercial Vehicle and Driver Services, Neil Kirkman Building, MS-62, 2900 Apalachee Parkway, Tallahassee, FL 32399-0626. Please keep in mind that when you are applying for a certificate of destruction on an out-of-state vehicle, you must have a Florida law enforcement officer do a VIN verification. We can no longer accept VIN verification's performed by other officials.
