
New CDL Testing Requirements

If you are a current CDL holder and you are upgrading or adding an endorsement that requires a skills exam (Passenger and School Bus), you will now be required to retake the CDL General Knowledge exam.

WHAT DOES THIS MEAN FOR YOU?

If you are upgrading from a Class B to a Class A, you will now be required to retake the CDL General Knowledge exam.

If you previously held a CDL and downgraded to a Class E driver license but would like to go back to a CDL, you may be required to retest depending on the length of time you have not had a CDL.



There are no additional fees for the retest, provided you pass the CDL General Knowledge exam the first time. If you fail the exam, you will be charged for each attempt.



Florida law requires you to **Move Over** a lane—when you can safely do so—for stopped law enforcement, emergency, sanitation, utility service vehicles and tow trucks or wreckers.

- If you can't move over—or when on a two-lane road—slow to a speed that is 20 mph less than the posted speed limit.
- Slow down to 5 mph when the posted speed limit is 20 mph or less.

When you fail to Move Over, you put yourself and others at risk; you could crash into a vehicle or worker.

Florida Insurance Requirements for Registration

Proof of Insurance from a certified Florida agent or broker is required to purchase and renew a license plate in Florida. The vehicle owner must present to the Tax Collector documentation of Personal Injury Protection (PIP) in the amount of at least \$10,000 and Property Damage Liability (PDL) insurance in the amount of \$10,000. Motorcycles, vessels, mobile homes and trailers are exempt from insurance requirement for registration.

As per Florida Administrative Code, Rule 15A-3.006, a Florida insurance card is acceptable only if it contains the following information:

- Company Name
- Florida Company Number
- Indicate Type of Coverage (PIP, PDL and/or BIL)
- Effective Dates of Coverage
- Name of the Insured
- Vehicle Year, Make and VIN Number
- Verbiage indicating that the card is not valid more than one year from effective date
- Warning of violation of Section 316.646, FS
