WHEN SHOULD THIS FORM BE USED?

- 1. WHEN A MOTOR VEHICLE, FOR WHICH AN ODOMETER DISCLOSURE IS REQUIRED, HAS BEEN SOLD.
- 2. WHEN A MOTOR VEHICLE, FOR WHICH AN ODOMETER DISCLOSURE IS REQUIRED, HAS BEEN PURCHASED.
- WHEN AN ODOMETER DISCLOSURE STATEMENT AND ACKNOWLEDGMENT BETWEEN THE BUYER AND THE SELLER IS REQUIRED, BUT NO ODOMETER DISCLOSURE STATEMENT HAS BEEN MADE ON ANOTHER STATE OR FEDERAL FORM.

WHEN SHOULD THIS FORM NOT BE USED?

- 1. WHEN A FLORIDA TITLE WHICH WAS ISSUED ON OR AFTER APRIL 29, 1990 IS AVAILABLE.
- 2. WHEN A FORM HSMV 82994, MOTOR VEHICLE DEALER TITLE REASSIGNMENT SUPPLEMENT. HAS BEEN USED.
- 3. WHEN A FORM HSMV 82995, MOTOR VEHICLE DEALER POWER OF ATTORNEY/ODOMETER DISCLOSURE, HAS BEEN USED.
- 4. WHEN AN OUT-OF-STATE TITLE, WHICH CONFORMS TO FEDERAL LAW, IS USED TO TRANSFER A MOTOR VEHICLE.

FILING:

- COPIES SHOULD BE EXCHANGED BETWEEN THE SELLER AND THE BUYER. DEALERS MUST RETAIN THIS DOCUMENT IN THEIR RECORDS FOR A PERIOD OF FIVE YEARS.
- 2. IT IS NOT NECESSARY TO FILE THIS FORM OR ANY COPY OF THIS FORM WITH THE STATE OF FLORIDA, UNLESS REQUESTED TO DO SO BY THE DIVISION OF MOTOR VEHICLES.

Open Titles:

A certificate of title submitted for transfer without the purchaser's name being shown in the "Transfer of Title by Seller" section <u>must</u> be rejected. The license plate agency personnel <u>must</u> highlight the open area and stamp the title with their county stamp. This will serve as a red flag to any other agency that this was an open title and <u>must</u> be accompanied by the following:

- a. A bill of sale from the seller showing the name of the purchaser, the selling price and a complete description of the motor vehicle.
- b. Form HSMV 82993, Separate Odometer Statement and Acknowledgment completed by the seller and the purchaser verifying the odometer information, if applicable.

The bill of sale an form HSMV 82993, Separate Odometer Disclosure Statement and Acknowledgment, must be attached to the certificate of title being submitted for transfer.
