## **Upcoming Important Tax Dates**

Monday, 4/2/12 Current tax payments, <u>if delivered by mail or presented in</u>

person at a Tax Collector's office, are entitled to March

amount and are not delinquent.

**Tuesday**, **4/3/12** All unpaid 2011 real estate property taxes become delinquent.

At this time a 3% interest charge is added to the gross amount. All 2011 unpaid tangible personal property taxes become delinquent. At this time a 1.5% per month interest charge is

added to the gross amount.

Mid April Reminder notices sent for all unpaid 2011 real property and

tangible personal property accounts.

**Monday, 4/30/12** Last day to pay 2011 real property taxes with 3% penalty with

personal or business checks.

New applications for next year's (2012) property tax

installment payment plan due.

**Tuesday**, 5/1/12 Advertising costs are added to delinquent 2011 real property

accounts, certified funds are required for payment. 1.5% interest and advertising costs added to delinquent tangible

personal property accounts.

May List of delinquent real estate taxes advertised once per week

for three consecutive weeks, prior to tax certificate sale, in a local newspaper. List of delinquent personal property taxes

advertised in a local newspaper one time.

**Thursday, 5/31/12** Last day to pay delinquent real property taxes before tax

certificate is issued.

Last day to pay delinquent personal property accounts before

tax warrant process begins.

Friday, 6/1/12 Tax certificate sale conducted for delinquent real property

taxes. Tax warrants issued on delinquent personal property

taxes.

## **On-Site General Tax Administration**



The Florida Department of Revenue and George Albright, Tax Collector of Marion County have agreed to conduct a pilot program to provide on-site General Tax Administration services at the Marion County Tax Collectors facility located at McPherson Complex, 503 SE 25th Ave, Ocala, FL 34471. At the Marion County Tax Collector's main facility, DOR will provide registration, tax processing, collection and taxpayer assistance services every Tuesday and Thursday beginning January 3rd, 2012. Their services will be provided between 8:00 AM and 5:00 PM closed 11:30 AM to 12:30 PM for lunch.
