Installment Payment Option

Did you know the Florida Statutes allow an alternative to an annual tax payment? You can pay your 2013 and future year taxes in installments. There is no fee to apply but to qualify your 2012 taxes must be at least \$100. Go to <u>www.mariontax.com</u> and under Property Taxes select Installment Plan. There you can click on the DR534 link to print an application. You may also call our office at 352-368-8200 to have an application mailed to you or complete an application when you bring your payment in. Applications must be received by Tuesday April 30, 2013. And if you have signed up for the electronic Tax Notice the installment tax notice will be delivered to your inbox.

Florida Birth Certificates Offered at Two Local Tax Collector Offices


The Marion County Tax Collector George Albright proudly announces that tax collectors statewide can now issue birth certificates for any Florida born person. Mr. Albright devised the plan in conjunction with the Governor's office and the Florida Department of Health, which currently is the sole source for Florida birth certificates, through the county health departments. Marion County and Nassau County were the first Tax Collector offices with approval to currently participate in this statewide program.

Florida residents can obtain a birth certificate regardless of which Florida county they were born in. The price for a certified birth certificate will be the current rate of \$13.00, plus \$7.00 for any additional certificates for the same person processed at the same time.

Ultimately all 8 of Albright's offices will be able to issue, however, currently only the main office located at 503 SE 25th Avenue in Ocala, the Belleview branch located in the Winn Dixie shopping plaza, the North Branch in the Sweetbay shopping plaza and the Dunnellon branch located at 19995 SW 86th St in Dunnellon will be able to issue the certificates.
