Registration Fee Reduction

The Florida Legislature has recently passed a bill that will lower the cost of motor vehicle registrations by up to \$25.00 per year. The legislative change will to take effect September 1, 2014.

In an effort to save you money, the Marion County Tax Collector recommends renewing your motor vehicle registration for one year versus two years. There is no cost advantage with two-year registration renewals. Refunds will not be given for any registration issued prior to September 1, 2014.

Medical Examiner's Certifications

If you are a current CDL holder and are required to maintain a Medical Examiner's Certification, you will be required to be examined by a medical examiner listed in the National Registry of Certified Medical Examiners for any Medical Examiner's Certificate that is issued on or after May 21, 2014.

Medical Examiner's Certificates issued on or after May 21, 2014 that do not include the National Registry number will be invalid and the CDL holder will need to provide a valid Medical Examiner's Certificate to maintain or be issued a CDL.

Medical Examiner's Certificates issued before May 21, 2014 that have not expired with no National Registry Number will be accepted as a valid medical card as part of the self-certification.
