## Filing 2290's at the Tax Collector's Office

To better serve you, the Marion County Tax Collector has made special arrangements with the IRS to make it easier for you to register your truck. At your option, we will forward your completed Form 2290, Schedule 1, and remittance to the IRS on your behalf. You will not have to wait for a receipted Schedule 1 from the IRS then revisit us to register your truck. Your participation in this service is entirely voluntary.

Upon acceptance of your completed Form 2290, Schedule 1, we will also process your truck tag registration, making this a one day process!

### If you decide to use this service, this is what you do:

Submit the following in person to any tax collector office:

- the completed original Form 2290,
- 2 copies of Schedule 1,
- payment in full of the amount due (personal check, money order, bank or cashier's check payable to the United States Treasury).
- your truck registration with the payment in full of the amount due (cash, personal check, money order, bank or cashier's check, credit card (VISA not accepted) payable to Marion County Tax Collector.



### If you decided to use this service, this is what we do.

We will review your return for completion of certain entries. We will mail your return and payment to the IRS on the business day following receipt of your return. However, you will leave our office with your truck tag registration renewed the same day you come into our office.

### What you need to know.

The IRS does not consider your return filed for federal tax purposes until the IRS receives it. If the IRS receives the

Form 2290 after the due date, the postmark date on the envelope will be the date the return is deemed filed. The IRS is not responsible for any delays or mishandling of your return or remittance before the IRS receives it. You are liable for any tax, penalties and interest that may be due. If the IRS determines you owe additional amounts, they will bill you directly after they receive the return.

Use of this system does not change the due date for your return and payment. For example, if your highway use tax return is due August 31st, you cannot wait to file and pay the tax with your state registration that is up for renewal on November 30th.

You should also be aware that this program will not work if you are registering vehicles in more than one state.

This office is voluntarily offering this service to registrants. We are not reimbursed for this service. We are not an agent or contractor of the IRS. We do not receive confidential return information from the IRS records of your account.

## **Repossessions with Subsequent Lienholders**

If you are the primary lienholder on a title and you are attempting to apply for certificate of repossession on a title that has a subsequent lien, you must submit the following:

- A lien satisfaction
- or,
- A copy of the HSMV 82048, Repossession Notice to Subsequent Lienholder, or a copy of the notice of intent to repossess on letterhead stationary and the original or certified copy of the post office returned receipt for the certified mail or the returned unclaimed certified letter, which was sent to the subsequent lienholder.



The subsequent lienholder has 15 calendar days from the date the notice was mailed to provide written protest to the department at which time an administrative stop will be placed on the database. Since there is a period of 15 calendar days, not including the date of the notification, for the subsequent lienholder to notify the department, any applications received within that 15 day time period shall be rejected. The lienholder must resubmit the application after the 15 day time period has passed.

- As with anything, change is constant. Please keep in mind when you are changing title clerks that it is your responsibility to contact your vendor and notify them of any user changes. They must have that information on file to forward to DHSMV, who in turn will give your clerk authorization to access the system. - When transferring electronic titles and you are using 82994's, please make sure that you are checking to make sure you have the correct seller signing. Please make sure you are double checking everything prior to finalizing your work and sending it to us. Double checking your work will cut down on the number of errors we have to correct!
