



DMV's New Technology

The Division of Motor Vehicles' *Bureau of Field Operations* investigates complaints made against motor vehicle, mobile home and recreational vehicle dealers. Dealer complaints may vary in reason, but the most common

complaint is failure to apply for title and registration for their purchaser within 30-days



of delivery as required by law. The bureau has developed a program by using new technology to assist them in monitoring those in violation. On the last day of each month they will print a report that will list the title number, acquired date, transaction date and dealer license number for any transaction(s) that were completed after the 30-day time frame. Dealers will then receive a letter from the department reflecting these transactions. The letter will encourage the dealer to complete the title process within the 30-day time frame as allowed by Florida law.

In addition, if a pattern develops, the department will levy sanctions against the dealer in violation of the statutes or rules administered by the department. These penalties may include:

- Fines up to \$1000 per violation
- An Order of Emergency Suspension, which may be issued to protect the public in serious cases
- Revocation of the dealer's license

The Bureau wishes to work with the dealers to educate them of the requirements of the law, notify them of violations and to encourage them to transfer titles and registrations within a timely manner. If you receive a letter from the department and have questions regarding it, please contact your local DMV Regional Office.

Expedited Titles

In August 2004, the department piloted a project that would allow electronic titles to be printed on demand under specific circumstances. This process is called "Expedited Title". The intent of this process is to provide participants of the ELT program a more efficient way of obtaining a paper title.

Expedited title is only available on records that have electronic liens. When the lienholder releases their lien, they can systematically indicate for an expedited title. The request is held in our system until the owner, dealer or lienholder requests the title to be printed. This request must be made by 2:00 P.M. for the title to available for printing the following business day. The fee for this process will be a \$7 fast title fee.

Expedited title provides better customer service. The consumer, dealer or third party needing the title can pick it up as quickly as one day. Mail time is eliminated, postage or overnight courier is avoided as well as forwarding titles to the ultimate destination.

Customers With Driver License Stops



When the department

processes a title transaction and *a lien is being recorded*, if the new owner(s) has a stop on their driver license and we are renewing or extending the registration expiration period, the department will

now do a title only transaction. In the past we would have returned all the paperwork until the stop was cleared. We will now transfer the title into the purchaser's name and record the lien to secure the title for the lienholder. The customer will not be able to extend their registration period until the stop has been removed. This applies regardless of which owner has the stop against their driver license, owner or co-owner. Emergency Contact Notification

Effective Monday October 2, 2006 the department will offer customers, who hold a *current* driver license or

identification card, the ability to provide emergency contact information via the DHSMV website. The emergency contact information can be accessed through DAVID by law enforcement in the event of an emergency. They will be able to



swipe the license or ID Card like a credit card to retrieve this information. This service may save crucial time if it ever becomes necessary to contact family members or other loved ones for an emergency situation. Motorcycle Update

Beginning January 1, 2007 all motorcycles with a registrant under the age of 21 will be required to have a new Motorcycle Under-age Plate. The plate is unique in design and color to alert law enforcement of under age motorists. Existing motorcycle registrations, where a registrant is under 21, will be required to replace their current plate at time of renewal. After the registrant reaches the age of 21, the system will flag to replace the plate with a regular motorcycle plate. If you have any questions regarding this matter, please contact our office.

Effective Dec 1st, 2006 the EFS fee that dealers can charge to their customer's has been increased from \$17.00 to \$24.00. If you wish to take advantage of the increase in the EFS fee, you may charge your customers per the EFS Program Standards, and you must submit a price increase request to your tax collector for approval. If necessary, please contact your Dealer Management System (DMS) provider to have your forms changed. If you have any questions concerning the price increase you may contact me at Marion County Tax Collector, EFS Department Pam Randle at (352)-368-8241.

As a reminder to all EFS dealers, if a vehicle has been traded in to your dealership you must mark title as sold. Then a disposal affidavit must be attached to paperwork letting me know what happened to vehicle.
