HEAVY TRUCK REQUIREMENTS

As of August 20, 2007 we will require that a bill of sale be submitted with every title transaction involving a truck tractor grossing over 55,000 lbs. in lieu of the required Schedule of Heavy Highway Vehicles (IRS Form 2290).

The bill of sale will show proof that the vehicle was purchased within 60 days prior to

the application for registration. The change in procedure was implemented to ensure that we are in compliance with IRS requirements.



TL-11 PROCEDURE CHANGES

When a certificate of title is submitted for transfer and the name of the purchaser entered in the "Transfer of Title by Seller" section has been lined through, altered, or is not



the same person applying for the title transfer, the owner of record must either provide a notarized affidavit as to the alteration or accompany the purchaser to the tax collectors office to provide a general affidavit as to the alteration or the owner must apply for an unaltered certificate of title.

The affidavit must be notarized, a perjury clause affidavit will not be acceptable.

DISPLAYING TEMPORARY TAGS

As we all know there are always questions concerning the proper display of the temporary tags. Normally you attach the temporary tag to the license bracket on the back of the car. Are we allowed to attach the



temporary tag to the back window? Yes, provided it is visible from the rear of the vehicle. You can not place a temporary tag on the back window that has heavy tinting. With heavy tinting and night driving, law enforcement may have difficulty seeing the tag.

PERSONALIZED LICENSE PLATES

As many of you have come across, some customers would like to order their personalized license plate when they purchase their new vehicle. Please remember to fill out DHSMV form 83043, Application for Personalized License Plate to submit their request.



DMV procedure RS-27 clearly states that the application “MUST include the true

meaning of the license plate in the Reserved Plate Explanation field”. Until an adequate explanation is received, no further consideration is given for the tag, which slows the processing time down considerably.

Tallahassee reviews personalized license plate orders and configurations found to be obscene or objectionable are deleted from the order regardless of whether it is an original or 5-year mandatory replacement.

All personalized orders can take up to 12 weeks to process.

ELT LIENHOLDER LIST

With the recent changes that have taken place, we all know how important it is to keep up with new updates. The ELT Lienholder lists is constantly being updated to add new lienholders. Here's how to get the most recent copy online:

LIEN RELEASES

Just recently we have had several inquiries regarding the time frame in which the lienholder has to release a title.

Florida statute 319.24 (5) (a) states “...A motor vehicle dealer acquiring ownership of a motor vehicle with an outstanding purchase money lien, shall pay and satisfy the outstanding lien within

10 working days of acquiring ownership. The lienholder receiving final payment as defined in s.674.215 shall mail or otherwise deliver a lien satisfaction and the certificate of title indicating the satisfaction within 10 working days of receipt of such final payment or notify the person satisfying the lien that the title is not available...”



E - TITLE IMPLEMENTATION

As of August 15, 2007 Phase I of the electronic title process was implemented. Currently this process only affects customers whose Florida titles were held by electronic lienholders. If they pay off the vehicle, they will receive a letter in the mail stating that their lien was satisfied but it will remain electronic in the DHSMV database. Customers who wish to hold a paper title have the choice of coming to their local tax collectors office and requesting a paper title be printed immediately for \$7.

DHSMV form 82994, Motor Vehicle Title

Reassignment Supplement, has been modified to allow the owner to reassign ownership when a vehicle is traded to dealer.

Dealers must make sure the lien has been satisfied and the record is electronic before re-assigning the vehicle to another dealer or a new purchaser. This can be accomplished by visiting the DHSMV website and clicking on <http://www.hsmv.state.fl.us> and clicking on "Motor Vehicle Check.



E - TITLE SCENARIOS

Customer Trades Vehicle That Has An ELT Lien

- ◆ Dealer and customer complete secure Power of Attorney (DHSMV form 82995).
- ◆ After checking DMV website, if title is electronic, dealer and customer complete revised reassignment form (DHSMV form 82994, rev. date 4/07). Under these conditions please treat the 82994 as a title.
- ◆ Dealer sends payoff to lienholder. System will show lien satisfied. Dealer has option of continuing electronically or printing paper title in customers or dealership name.

Dealer Sells Previous Customers Traded Vehicle With E-Title

- ◆ Dealer and new customer complete old reassignment form (DHSMV form 82994, rev. date 1/03).
- ◆ Dealer takes title application (DHSMV form 82040), new 82994, old 82994 and all other paperwork to tag office without title to transfer vehicle into new customers name.



Dealer Decides To Sell Trade-In Vehicle At Auction

- ◆ Dealer produces letter from DMV regarding payoff or a fast title authorization.
- ◆ Dealer pays \$7 fast title fee to receive customers title or applies for title in dealerships name (with completed 82040).
- ◆ Dealer completes title by using the secured Power of Attorney (DHSMV form 82995).
- ◆ Dealer brings completed title and 82995 to auction and sells car.

DEALER LICENSES

There will be no recertification classes held in Ocala from now until January. VF licenses expire December 31st. For those VF dealers that are up for recertification, please visit www.fiada.com to complete the process online. Please keep in mind that only an owner, partner, corporate officer or GM can complete the online course. Once you complete the course, you will be able to print out your own certificate of completion.



If your license expires on December 31st and your license has not been renewed for 2008, we will not be able to process your work dated after December 31st until you have completed all your license renewal requirements.



DEALER REASSIGNMENT FORMS

Please make sure that you are ONLY using the new Dealer Reassignment Supplement (DHSMV Form 82994, rev. 04/07) when you are taking a vehicle in on trade that has an electronic title. When you sell the vehicle that you have taken in on trade with the electronic title, you will use the old Dealer Reassignment Supplement (DHSMV Form 82994, rev. 01/03) to reassign to your new customer. Under no circumstances should there be more than one 82994 (revision date 4/07) attached with any deal.

You do not need to use an 82994 when you have the Florida title in your hand and the customer is signing the title.

DRIVERS LICENSE CHECK

Have you ever had that customer where they weren't sure if their license is suspended or close to being suspended? Now you can go online and check your customers drivers license status in 3 easy steps!

- ◆ Go to www.hsmv.state.fl.us
- ◆ Click on Drivers License Check under Online Services.
- ◆ Enter the customers drivers license number and click enter.



You will be able to see if the license is valid, what class license, restrictions, endorsements and expiration date.

DMV APPROVED FORMS

Please make sure that all forms you are submitting have been approved by the state. We understand that some of the dealer software prints out its own version of our forms, prior to accepting them we would have to review them to make sure the wording is the same or similar to ours.



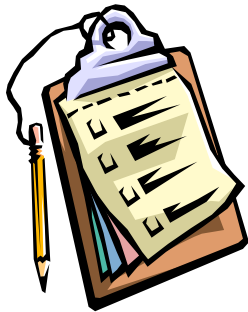


EFS UPDATES

PENDING STATUS

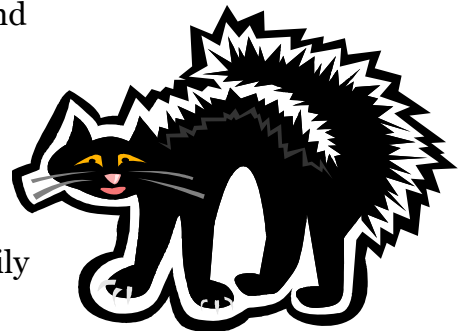
As you are all aware, when you don't finalize a deal that you have processed it will automatically show as a pending transaction on our daily reports. We understand that sometimes your hands are tied because of a lien satisfaction, missing POA or you are just waiting for a title. These deals can not be in pending status for more than 30 days. If you have deals that are pending for more than 60 days, they need to be backed out and walked through. Tallahassee monitors these reports daily and is aware of deals that remain in pending status.

SEPTEMBER 2007 NEWSLETTER RECIPE OF THE QUARTER

PUMPKIN BAR WITH FROSTING

1 (16 OZ.) CAN PUMPKIN 1 2/3 C. SUGAR
2 TSP. BAKING POWDER 4 EGGS
2 C. POWDERED SUGAR 1 TSP. SALT
1 TSP. BAKING SODA 1 C. OIL
2 TSP. CINNAMON 1 TSP. VANILLA
1/2 C. BUTTER 2 C. FLOUR
1 (3 OZ.) PKG CREAM CHEESE

In mixing bowl beat together: pumpkin, sugar, eggs, and oil until fluffy. Mix together flour, baking soda, baking powder, cinnamon, and salt. Add to the wet mixture. Pour onto a cookie sheet and bake at 350° for 25-30 minutes.

Prepare frosting by beating the following ingredients: powdered sugar, butter, cream cheese and vanilla. Frost pumpkin bar after it cools.
