Emergency Contact Information

Have you ever asked yourself, what if you were in a crash or other emergency situation and you couldn't talk, your cell phone was locked or you didn't have access to it? How would your friends and family be notified?

If you register your emergency contact information (ECI) into the Department of Highway Safety and Motor Vehicles system, Law Enforcement can contact your loved ones for you quickly and even across state lines.

ECI is a secure system that Law Enforcement nationwide can access in order to contact your designated family or friends in response to an emergency situation. Only Law Enforcement has access to your emergency contact information and this information is only used to notify the contacts that you designate in the event of an emergency.

The ECI system was first developed in Florida because there was no emergency contact program in place to quickly notify loved ones in the event of an emergency. ECI was initiated by Christine Olson in loving memory of her daughter Tiffiany because she was involved in a fatal crash and it was over 6 hours before Christine was notified. Concealed Weapon License Hours & Fees

During the last year applicants have been able to apply for their statewide concealed weapon license at the office of Honorable George J. Albright III, Tax Collector by appointment only. The Marion County Tax Collector’s Office is now accepting new concealed weapon license and renewal applications on a **walk-in basis** at the McPherson Government office from 8:00 AM to 4:00 PM.

Florida concealed weapon licenses are processed by the Florida Department of Agriculture and Consumer Services. Due to rising demand, Tax Collector offices have been given authority to take applications, fingerprint the applicants and send the information securely to the department for final determination. The actual issuance of the permits will be from Department of Agriculture in Tallahassee.



Veteran Designation on Driver License

Any US veteran discharged or released as “Honorable” or “Under Honorable Conditions” may have a Veteran Designation placed on his or her driver license. The veteran will need to provide a copy of their DD-214 or other approved discharge document at the time of issuance. The designation currently appears on the license as a “V”.



To place the Veteran designation on your current driver license is \$8.25 if we are not making any name or address changes. To place the Veteran designation on your driver license while making address or name changes is only an additional \$1. To add the Veteran designation during the time of renewal is only an additional \$2.

Veterans who need to obtain a copy of their DD-214, may request it through the National Archives, which provides information on how to make the request online at www.archives.gov/veterans/military-service-records/.

Please contact our office at 352-368-8200 for more information or to verify if the documentation that you have will be sufficient to add the Veteran designation.

Florida Birth Certificates

Do you need a Florida birth certificate to enroll your child into school? Do you need your Florida birth certificate to renew your driver license? Did you know that the Marion County Tax Collector's Office began issuing Florida birth certificates in 2013?

We now offer the birth certificate services at 6 of our locations. You may visit our Main Office located at 503 SE 25th Ave in Ocala, the Belleview branch located in the Winn-Dixie shopping plaza, the Summerfield branch located in the Spruce Creek shopping plaza, the North branch located in the Winn-Dixie shopping plaza, the Dunnellon branch located at 19995 SW 86th St in Dunnellon and our Forest branch located in the Winn-Dixie shopping plaza in Silver Springs.


The cost to apply for a birth certificate in our office is \$18.00, plus \$7.00 for any additional certificates issued for the same person at the same time.
