CHANGES TO REAL ID IMPLEMENTATION

Due to the effect that COVID-19 is having on all aspects of our lives, The Department of Homeland Security has announced that they are extending the REAL ID enforcement deadline to October 1, 2021. This will give residents, that have not yet had the opportunity to become REAL ID compliant, an extra year to gather the necessary documents to comply with Federal Law.

COMMERCIAL DRIVER LICENSE CHANGES

Recently the State of Florida has made several changes to the Commercial Driver License issuance process. Here is what you need to know and how the changes will affect you.

- If you are in the process of testing for your Commercial Driver License, you must first pass the General Knowledge exam prior to taking any other test.
- Any written or skills testing that has not been applied to the record within one year of the CDL General Knowledge Exam pass date are not valid for issuance and will require retesting.
- During the issuance of the Commercial Driver License learner's permit, you will be required to self-certify how you expect to be operating the commercial vehicle. Some categories require a valid DOT medical card, which you will be required to present at that time.
- To ensure Commercial Driver License customers are knowledgeable of commercial vehicle driving laws and capable of demonstrating commercial driving skills, customers with CDL licenses that have expired for one year or more, will be required to complete and pass all applicable CDL knowledge and skills exams to obtain a CDL.

PROPERTY TAX DEADLINE EXTENSION

On March 26, 2020, Department of Revenue issued an emergency order extending the final due date for property tax payments for the 2019 tax year from March 31st to April 15th, 2020. This only applies to real estate and personal property taxes whether on the annual or installment plan.

- When paying your property taxes, enter your parcel account number on the comments line.
- Include your phone number with any other notation on the comments line.
